CONDITIONS OF CERTIFICATION

1. When applied to a non-combustible substrate
2. PVC based floor covering consisting of: urethane acrylate surface coating applied at rate 12-16g/m², followed by one layer of 'Clear Wear Layer (1)' plasticised PVC film, thickness 150µm, manufactured by The Amtico Co Ltd, followed by one layer of 'Clear Wear Layer (2)' plasticised PVC film, thickness 370µm, manufactured by The Amtico Co Ltd, followed by one layer of print design film 'SW2550' thickness 75µm, followed by one layer of filled core 'Marine Core' filled plasticised PVC thickness 760µm, manufactured by The Amtico Co Ltd., followed by one layer of filled backing 'Marine Blueback' filled plasticised PVC thickness 510µm, manufactured by The Amtico Co Ltd
3. Bonded to substrate with adhesive 'Amtico SF' at rate up to 3 – 3.5m²/kg or adhesive 'Amtico HTE' at rate up to 2 – 2.5m²/kg
4. Total thickness of flooring after manufacturing process complete: 2.0mm, weight 2.85kg/m²
5. Composition and application of individual components including any fire retardants, heat stabilisers and adhesives to be maintained in production in accordance with originally tested composition formula
6. The certificate holder is solely responsible for the products supplied under this Certificate and to ensure that their products, whether manufactured by themselves or their licensee manufacturers, if agreed by Lloyd's Register, are fully compliant with the relevant statutory regulations and Lloyd's Register Class rules as applicable and designed and manufactured to the same quality and specifications as the prototype tested, including components that are designed and manufactured by third parties
7. Production items of the subject equipment are to be manufactured in accordance with either an approved Production Quality Assurance system (Module D), a Product-Quality assurance system (Module E) or a Product Verification Process (Module F). The wheelmark cannot be affixed to the product until a conformity assessment module is in place
